**ORDER**

Whereas, World Health Organization (WHO) has declared the outbreak of Novel Corona Virus (COVID-19) as a Pandemic on 11.03.2020,

And whereas, Govt. of NCT of Delhi vide Notification no. F.51/DGHS/PH-IV/COVID-19/202-215 dated 12.03.2020 has notified "The Delhi Epidemic Diseases, COVID-19 Regulations, 2020.


And whereas, Section 30 of the Disaster Management Act, 2005, read with Section 34 of the said Act, empowers the District Authority to perform such functions as it deems necessary for disaster management in the district.

And whereas, clause 16 (IX) of The Delhi epidemic disease, COVID - 19 Regulations, 2020 authorizes the District Magistrate under the Regulations to take any measures as directed by Department of Health and Family Welfare, Govt. of NCT of Delhi in order to prevent of the spread of the disease.

And whereas, in the Video Conferencing, held on 05.05.2020, with District Magistrate of all the District, in which Hon'ble Dy. CM was also present, it was conveyed by the Chief Secretary, Delhi, that Govt. of India has contemplated a plan to bring back its citizens stranded in different parts of the world through the special flights, likely to be started tentatively from 07.05.2020 tentatively for which the protocol of screening of each and every passenger is required to be followed including to create paid quarantine facilities in the hotels located in New Delhi Revenue District for those, who voluntarily like to avail that facility, in lieu of the Govt. institutional quarantine facilities.

Now, therefore, I, Tanvi Garg, IAS, District Magistrate, New Delhi District, in exercise of power conferred under Act/ Regulations mentioned above, and in overall imminent public interest, do hereby require the management of Hotel Le Meridien, New Delhi to isolate 200 rooms and place at the discretion of Revenue Department, New Delhi District for setting up paid quarantine facilities on the terms and conditions as annexed herewith along with manpower and other resources as are essentially required to fully operationalize the requisite accommodations as institutional paid quarantine facilities with immediate effect.

**Non-compliance of this Order shall attract penal action as per Act/ Regulations in force.**

### Terms and Conditions

1. The rate of rooms, irrespective of its size, and facilities to be provided by the Hotel shall be as under:-

Particulars	Details
Rate per room	Rs. 4000/- + applicable taxes for single bed occupancy and Rs. 4800 + applicable taxes for double beded occupancy in two separate beds with minimum distance of 02 meters. These rates are the upper ceiling limit of room tariff to be charged by the Hotel from the beneficiary who intends to avail the paid quarantine facility. However, the Hotel is at liberty to charge a lower rate than the ceiling fixed vide this order.
Facilities to be provided in the rooms rates	<ol style="list-style-type: none"> <li>1. Three Meals (i.e Breakfast, Lunch &amp; Dinner) per day</li> <li>2. Two Bottles of Mineral Water per Day.</li> <li>3. Material for preparation of Tea &amp; Coffee in the room with requisite material as per standard practice.</li> <li>4. Other similar facilities as provided to normal guests of the hotel including WI-FI, Television etc.</li> </ol>

2. The payment shall be made by the actual beneficiary from the day the beneficiary occupies the room. However, request for payment of advance may be avoided.
3. Laundry facility, to be provided to such guests, shall be separated in such a way so that it does not mix up with the laundry facility of normal guest.

4. Meals to such guest shall be served in their rooms only in disposable plates/containers. The plates/containers used for this purpose should be disposed off as BIO-Medical Waste by ensuring due protocol by the Hotel at its own level in coordination with Director, Public Health, NDMC.
5. The hotel shall deploy their security personnel in such a way so that movement of these guests is restricted in the confined area. The management shall also observe the movement of these guests through CCTV in their control room.
6. The additional terms and condition, as decided by the District authority shall be binding on the hotel management.
