## **NOTICE INVITING TENDER (NIT)**

High Commission of India, Singapore invites financial bids from selected companies for supply and installation of LED lights, junction box and wiring etc at GoI property at No. 2 Pierce Road, Singapore 248554.

## Scope of work

The scope of work includes following:-

- 1. Lights at several locations of *India House* premises at No. 2 Peirce Road, Singapore 248554 are non-functional and some additional lights need to be installed to illuminate some areas. Bids are invited for supply labour, materials and tools to carry out the following works:
- i. To supply 25 sets of spotlights to the external garden area.
- ii. To supply 50 nos LED Lights (40 nos for internal Main Bungalow + 10 nos for Walkway corridor towards water feature)
- iii. To supply 50 meters LED Strip lights to Grand Staircase (40m left & Right + 10m below at left side).
- iv. To supply 3 nos of LED light drivers
- v. To supply new wires, MC Box and connectors and other related accessories
- vi. To supply 6 nos round bright LED lights at Grand Staircase (left and Right) including junction box and wiring
- vii. To supply 19 nos LED concealed square bulbs for Extension Corridor at Main Bungalow
- viii. Replacement of 2 nos. decorative ceiling lights at Main Bungalow family Living Room at Level 2.
- ix. To supply Electrician to install the light fittings

## **QUOTATIONS AND GENERAL CONDITIONS:**

- 2. The financial bid should be sealed by bidders in cover duly super-scribed "Financial bid for supply and installations of lights at India House at No. 2 Pierce Road, Singapore 248554". The financial bid shall be prepared in the format attached at Annexure B.
- 3. The premises and the scope of work may be inspected with prior appointments. Please call Tel. No. 62382536/35 for fixing appointment for viewing the premises.

- 4. The contractor shall not further sub contract the whole or any part of the contract, under any circumstances to third party. The Contractor should satisfy himself about scope of work before submitting the bid. In case of any dispute, the decision of High Commission of India shall be final. No deviation in specification shall be allowed and no extra claim shall be entertained for any unforeseen work.
- **5.** No claim from the contractor for any additional payment on account of local Singapore laws or on restricted working hours shall be entertained. The contractor must quote according to local laws and conditions at site.
- **6.** Water and electricity required for the proper and efficient execution of the works will be provided without charge by the client. Contractor and the workers shall exercise every effort to prevent the abuse of this privilege and to economize in the use of the water and electricity, and strictly comply with all rules and regulations applicable to the use of it.
- 7. The bidder is required to submit earnest deposit of S\$ 500.00 by way of bank guarantee or fixed deposits. The EMD shall be returned to unsuccessful bidders after completion of process of award of work. In lieu of EMD, bidders can also submit undertaking in the given format at 'Annexure A'.
