- 4. The payment shall be made within 14 days after completion of satisfactory work. In case of any lapse or short comings in the execution of work, deductions will be made by HCI. No advance payment will be made.
- 5. The bidder shall liase with the local authorities for any requirements like movements of truck/lorry, parking on road etc. HCI will not be liable to obtain any such permissions.
- 6. The work shall be carried out in such a manner that no damage is done to the property of High Commission of India. In case of any damage, the same shall be made good by the bidder immediately or the repair cost shall be covered from the Contractor.
