Terms and Conditions:

- 1. The premises can be inspected any day between 10:00 a.m. to 1:00 p.m. from 09^{th} Dec 2022 to 28^{th} Dec 2022 with prior appointment.
- 2. The bidder should clearly understand the requirement in respect of size of tents, location, layout of tent and other requirements. The work shall be carried out as per requirements indicated during inspection. The tent, chair and table covers must be of white colour and clean.

- 3. The installation of stage, tents and other setup should be completed one day prior to the event. The successful bidder shall ensure timely completion of the installation. The contractor shall dismantle the installations after the event and should remove from HCI premises by next day.
- 4. The payment shall be made within 14 days after completion of satisfactory work. In case of any lapse or short comings in the execution of work, deductions will be made by HCI. No advance payment will be made.
- 5. The bidder shall liaise with the local authorities for any requirements like movements of truck/lorry, parking on road etc. HCI will not be liable to obtain any such permissions.
- 6. The work shall be carried out in such a manner that no damage is done to the property of High Commission of India. In case of any damage, the same shall be made good by the bidder immediately or the repair cost shall be borne by the Contractor or recovered from the performance guarantee.
- 7. The financial bids must be sent in a sealed cover or by email to property.singapore@mea.gov.in by 30th Dec 2022. The bids should be addressed to "Head of Chancery, High Commission of India, No. 31 Grange Road, Singapore 239702."
- 8. At the time of award of work, the company shall submit a **performance guarantee** in the form of banker's cheque, bank draft or bank guarantee equal to 10% of the contract value. The Performance Guarantee shall remain valid for a minimum period two months.
- 9. High Commission of India reserves the right to reject any bid and doesn't bind itself to accept the lowest bid or any bid and can scrap the whole process without assigning any reason. No claim whatsoever in this regard shall be entertained.

10. Any conditional bids shall not be accepted by the High Commission. The unsolicited bids will not be considered.
