### **NOTICE INVITING TENDER**

1. The High Commission of India invites financial bids from reputed companies registered in Singapore for the following work at No. 31 Grange Road, Singapore 239702.

## 2. General Conditions of the contract:

- (a) The Contractor will liaise with the concerned authorities on behalf of High Commission for obtaining requisite permission for (i) construction of fencing (ii) removal of roots/branches of trees inside along the perimeter of the premises.
- (b) The premises and the work to be carried out may be inspected from Monday to Friday from 1000 hrs to 1600 hrs. Mr. S K Goel, Head of Chancery can be contacted for viewing the premises and understanding various aspects of work, in case of any doubt.

- (c) The work shall be completed within three weeks of date of award of work. Any hindrance or any other situation warranting extension of time should be informed to High Commission of India immediately on its occurrence.
- (d) A rough sketch of the work to be carried out is enclosed with this NIT. However, this may be noted that there can be change in actual execution of work depending upon site conditions. No extra claim, whatsoever, shall be entertained in this regard.
- (e) The repair and replacement work of PVC chain link/iron post/concrete base/brick work shall be of specification same as that of the existing one. In case of any variation or any requirement for the strengthening of fencing, the decision of High Commission of India shall be final.
- (f) The Contractor should satisfy himself about scope of work before submitting the bid. In case of any dispute, the decision of High Commission of India shall be final. No deviation in specification shall be allowed and no extra claim shall be entertained for any unforeseen work.
- (g) No claim from the contractor for any additional payment on account of local Singapore laws or on restricted working hours shall be entertained. The contractor should satisfy himself and must quote according to local laws and conditions at site.
- (h) The work shall be carried out in such a manner that no part of the fencing is open after the office hours. The Contractor shall ensure that site is well protected and secured during all the time. No extra charges will be paid for this to the Contractor.
- (i) The Contractor shall ensure that all local labour laws and other relevant provisions in force from time to time are fulfilled and insurance provisions are made for the safety of workers at site. The Contractor shall have to settle all claims arising out in the performance of the contract and the High Commission of India shall not be liable on any account.

#### 3. General Conditions of bidding:

- (a) The financial bids in the prescribed format should be submitted on or before 17 August 2019 and should remain valid 31 October 2019.
- (b) The bid should be accompanied with Earnest money of SGD 500/-. The earnest money shall be returned back to unsuccessful bidders as soon as award of work is finalised but no later than 15 December 2019.
- (c) In case a bidder is not able to submit earnest money, a declaration as enclosed would be required to be submitted.
- (d) The earnest money should be in the form of bankers' cheque, fixed deposit receipt, account payee demand draft or Bank guarantee. This earnest money should remain valid till 15 December 2019.
- (e) Financial bids not accompanied with earnest money shall be rejected.
- (f) On award of work, the successful bidder will have to submit Performance Guarantee equivalent to ten percent of value of contract. The PG can be in form of bankers' cheque, fixed deposit receipt, account payee demand draft or Bank

guarantee. This PG should remain valid sixty days beyond the completion of obligations under the contract.

- (g) On receipt of Performance Guarantee by the successful bidder, the earnest money shall be returned.
- 4. Defect Liability Period shall be one year from the date of completion of work. A security deposit of 10% of total cost of work shall be retained with High Commission for a period of one year from the date of completion of work. In lieu of this amount, the contractor can also submit bank guarantee of equivalent amount valid for a period of one year.
- 5. Financial bids should be sent in sealed covers addressed to "Head of Chancery, High Commission of India, 31 Grange Road, Singapore 239702 latest by 17th August 2019.
