Terms and conditions:

- 1. The premises can be inspected any day between 10:00 a.m. to 1:00 p.m. from 12th July 2021 to 26th July 2021.
- 2. The bidder should clearly understand the requirement as regards size of tent, location, layout of tent and other requirements. The work shall be carried out as per requirements indicated during inspection. The tent, chair and table covers should be of white colour and clean. Dirty tent or covers shall not be accepted and will have to be replaced by the bidder before the event.
- 3. The installation of tentage should be fully completed one day before the event. The bidder shall ensure timely start setting up of tentage for completion of the work in time. Ideally, it should be start 3-4 days in advance.
- 4. The dismantling should be done immediately after the event.
- 5. The amount may be quoted in one lump sum in SG dollars. Due to COVID 19 pandemic and restrictions in place, the requirement of tentage may be curtailed or cancelled without any notice. In case of any curtailment on scope of work, the payment would be made on pro-rate basis as per quoted rates.
- 6. The payment shall be made within 14 days after satisfactory completion of the work. In case of any lapse or shortcomings in the execution of work, the payment will be made pro-rata.
- 7. No advance payments will be made.
- 8. The bidder shall liase with the local authorities for any requirements like movements of truck/lorry, parking on road etc.

- 9. The work shall be carried out in such a manner that no damage is done to the property of High Commission of India. In case of any damage, the same shall be made good by the bidder.
- 10. The bidder shall provide tables etc. to meet any requirements of audio-visual company.
- 11. The quote must be sent in a sealed cover and should be addressed to "Head of Chancery, High Commission of India, 31 Grange Road, Singapore 239702".
