NOTICE INVITING TENDER

<u>Tender for laying of hollow pipeline from Main Gate 2, Peirce Road (India House) to internal Distribution board (app. 200 metres) and to two bungalows 2A and 2B, Peirce Road (app. 300 metres each)</u>

High Commission of India, Singapore invites bids for_laying of hollow pipeline from Main Gate 2, Peirce Road (India House) to internal Distribution board (app. 200 metres) and to two bungalows 2A and 2B, Peirce Road (app. 300 metres each). The pipeline specifications have been provided in the as follows:

"Laying of PVC pipeline 75mm Ø (dia) and 5 mm thick for making provision for laying of fibre optic cable from Main Gate at 2, Peirce Road to Internal DB (India House) and to two Bungalows 2A and 2B at 2, Peirce Road. The work shall include cutting and making good of garden, roads, drains, pavements etc."

The scope of work is as follows:

Supply and installation of one (1) lot incoming new fibre optic cables from existing Switch room to existing SCV DB of 3 units (Main Bungalow, 2 A New Bungalow & 2B New Bungalow) c/w draw pits 300mm X 300mm depth, lead in pipe 75mm ② (Diameter) fibre optic cables complete with all necessary ancillaries and accessories for the complete	
	operation of the system.	
2.	Contractor shall liaise with Net Trustlink to obtain cable readiness.	

1. Scope of Services:-

- (a) The scope of services includes the following:
- i) The contractor shall carry out the work as per specifications required for laying of fibre optic cable in consultation with service provider like M/s Singtel Or M/s Starhub.
- ii) The work shall be executed in such a manner that no hinderance/disruption to existing services is caused. In case of any damage, the contractor shall make good or restore the damaged service to the original position.
- iii) The work shall be completed in 15 days from the date of start of work.
- iv) Any liaisoning with service provider should be done by the contractor only. The High Commission shall facilitate in providing access to the areas inside building, if required.
- v) The contractor shall submit layout plan of pipeline alongwith details of inspection pit in the form of "as-built" drawing.
- vi) The contractor shall not share with anyone the layout of building plans and other details. Complete confidentiality shall be maintained for the purpose.

2. Evaluation of bids:

- (a) The financial bids shall be submitted in the format provided above and shall be evaluated by the committee of High Commission of India and decision taken for award of work shall be final.
- (b) The work shall be commenced immediately given the urgent requirement of laying of fibre optic cable.
- (c) The High Commission shall be at liberty to terminate the work if not carried out according to requirements OR as per service providers requirements.

(e) Last date for submission of bids:-

Bids, in the given format and complete in all respects and in the manner provided, may be submitted at the address given below by 14 May, 2019.

- (f) All data, information, and any other material submitted by the contractors/bidders in the process of bidding and part of bidding documents, shall remain the exclusive property of the High Commission at all times.
- (g) The bid and all correspondence and documents relating to the bid, exchanged between the bidder and the HCI shall be in English language or submitted along with the English translation.
- (h) The price to be quoted by the bidders shall be in Singapore Dollars only. The bid should be valid for a minimum period of 30 days.
- (i) The Bid shall contain no alteration, omissions or additions, overwriting except those to comply with instruction issued by the HCI or as necessary to correct errors made by the bidders, in which case the person or persons signing the Bid shall initial all such corrections.
- (j) The HCI reserves the right to accept/reject the Bid and does not bind itself to accept the lowest bid or any bid and can reject all the bids or scrap the proposal in whole or in part.

(k) The successful Bidder should not sub-contract any part of the Scope of work to be undertaken by them without written permission from the HCI. The bidder to whom the contract is awarded is solely responsible to the HCI for the completion of the awarded contract.
