1. The High Commission of India invites financial bids from reputed companies registered in Singapore for the following work at No. 31 Grange Road, Singapore 239702.

2. The Contractor will liaise with the concerned authorities on behalf of High Commission for obtaining requisite permission, if any.

- 3. The premises and the work to be carried out may be inspected from Monday to Friday from 1000 hrs to 1600 hrs. Please contact 62382533 for fixing appointment for viewing the premises and understanding various aspects of work.
- 4. After award of work, the work shall be carried out within three weeks.
- 5. The Contractor should satisfy himself about scope of work before submitting the bid. In case of any dispute, the decision of High Commission of India shall be final. No deviation in specification shall be allowed and no extra claim shall be entertained for any unforeseen work.
- 6. An amount of 10% of total bill will be retained as security deposit and shall be released only after one year of completion of work. This period of one year shall be 'Defect Liability Period' and any defects observed during this period shall be made good by the Contractor without any charges. The Security Deposit of 10% shall be fortified if the Contractor does not rectify damages within two weeks.
- 7. No claim from the contractor for any additional payment on account of local Singapore laws or on restricted working hours shall be entertained. The contractor must quote according to local laws and conditions at site.
- 8. The contractor might be required to carry out the work on Saturday Sundays or after office hours in case of those works which have high noise level. The work shall be carried out according to the availability of space and convenience of High Commission of India.
- 9. The material to be incorporated in the works shall be got approved by the High Commission or its authorised representatives. Any minor repairs to the wooden work which is needed for strengthening the work shall be carried out by the contractor and will not be paid for separately. Thus, contractor should examine the structure carefully.
- 10. The Contractor shall ensure that site is secured during the time of renovation at all the time. No extra charges will be paid for this to the Contractor.
- 11. The Contractor shall ensure that all local labour laws and other relevant provisions are fulfilled and insurance provisions are made for the safety of workers at site.
- 12. The bidder is required to submit earnest deposit of USD 500/- by way of bank guarantee or fixed deposits. The EMD shall be returned to unsuccessful bidders after completion of process of award of work. In lieu of EMD, bidders can also submit undertaking in the given format.
- 13. After award of work, the bidder shall submit performance guarantee of 10% of amount in the form of Bank Guarantee or FDs.

- 14. The Financial bid should contain lumpsum amount of each item without GST. GST shall be paid separately as per existing laws.
- 15. Financial bids may be sent in sealed covers addressed to "Head of Chancery, High Commission of India, 31 Grange Road, Singapore 239702 latest by 10<sup>th</sup> October 2019.
